1. *Ordinary shares*

Performance Rights were issued to Dr Jackie Fairley following shareholder approval at the 2013 Annual General Meetings (AGM), with a vesting date of 22 November 2016, subject to satisfaction of certain vesting conditions.

150,000 Performance Rights lapsed as the relevant performance conditions were not met.

100,000 Performance Rights vested as the relevant performance conditions were met and one ordinary fully paid share has been issued for each vested Right. These shares are subject to a one-year Holding Lock until 22 November 2017, provided that the shares may be released early in accordance with the Rules of the Employee Performance Rights Plan.

2. *Employee Performance Rights*

Performance Rights issued to Dr Jackie Fairley under the rules of the Starpharma Holdings Ltd Employee Performance Rights Plan (Rights Plan) on the terms set out in the Explanatory Memorandum accompanying the Notice of Annual General Meeting mailed to shareholders on 26 October 2016 and were approved at the AGM on 29 November 2016.

The Rights are subject to satisfaction of certain vesting conditions (there may be early vesting if certain events occur in accordance with the Rights Plan).

The Rights comprise two tranches with various vesting conditions and with the following vesting dates:

- Short Term Incentive (223,022 Rights)
– 30 June 2018
- Long Term Incentive (876,978 Rights)
– 30 September 2019

One ordinary fully paid share will be issued for each vested Right.
